

Trains for experimental High-speed rail passenger operations between New York and Boston - but the sleek trains may remain sidetracked for lack of insurance.

'Officials of the bankrupt New York, New Haven & Hartford Railroad, which is to operate the trains on the northern leg of the Northeast Corridor experimental program, say they're still shopping around for an insurance company willing to sell them what they consider to be sufficient liability insurance to protect the line against lawsuits once the high-speed trains go into service.

'Robert Blanchette, New Haven general counsel, said the road has obtained sufficient liability insurance to enable it to begin test runs for crew training and making schedules immediately after the government accepts the trains from United Aircraft Cor. in ceremonies next Monday at New London, Conn., midway point in the northern leg of the high-speed route.

'But New Haven officials believe considerably more insurance coverage is required before the high-speed trains start carrying passengers, and Blanchette added in a telephone interview, 'The question is how much insurance can be purchased in the open market'...'We're still shopping. We want enough to protect us against any reasonably foreseeable assessment of damages.'

'Blanchette explained that railroad liability insurance is a highly specialized market and there are few companies in the business, 'and it is not a readily obtainable commodity.'"

From the Silverton Standard of Friday, October 4, 1968,

'Today, Saturday and Sunday will wind up the 1968 season of 'The Silverton,'

Denver and Rio Grande Western narrow gauge between Durango and Silverton. Through

Thursday of this week, 85,230 passengers had arrived in Silverton by rail through the summer, nearly 6,000 more than last summer when 79,776 rode the train into Silverton.

Last year's runs stopped October 1.

Early this week, "Union Pacific" motive power moved the historic train into Silverton. Engines 473 and 478, repainted and redecorated in Union Pacific colors (and with numbers switched), have remained decorated until the movies filmed with them last month in the Animas Canyon and east of Durango have all been developed. Coaches have also retained their coloring, with the result that mixed colors have appeared almost every day this week. Tuesday, No. 476 went through its general monthly inspection, and one of the wash-out plugs wasn't properly replaced. The engine spewed steam all over the cab around 36th Street in Durango Wednesday morning, and the train had to back into the depot, where "Union Pacific" No. 478 replaced it and pulled the train into Silverton - an hour and ten minutes late.
